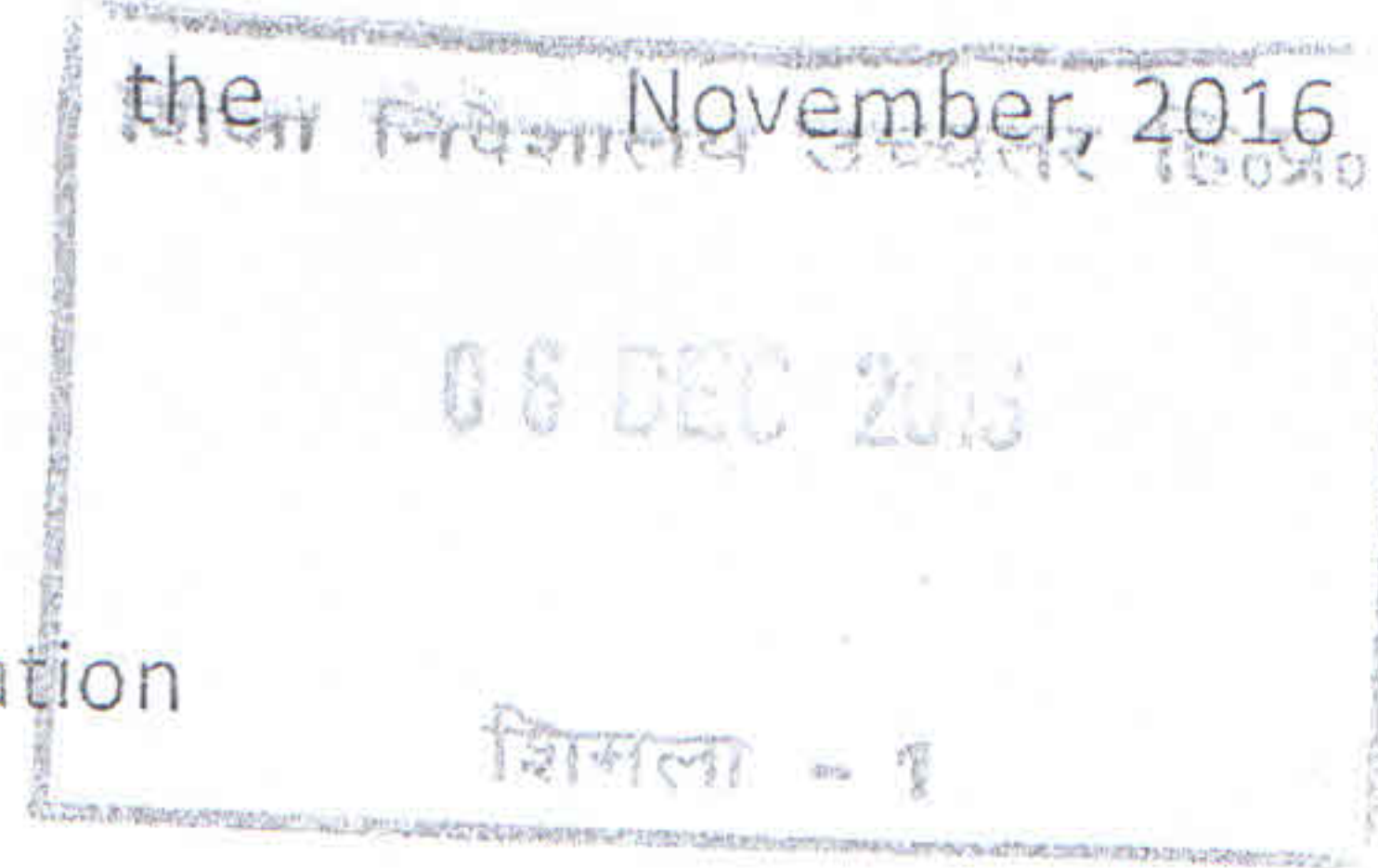



Regarding guidelines to the schools in respect of sanitation.

Subject:-
Sir,

I have been directed to inform the observations of the Commission for Protection of Child Rights which have been observed during its visits from time to time in the State in respect sanitation system in the schools. These observations have been made by the Commission:-

- a) Toilets should be made on the basis of strength of students.
- b) Separate toilets should not be made for teachers/staff of the educational institutions in view of cleanliness.
- c) Students should be made to wash their hands before every Mid-day meal.
- d) Cleanliness near the place of preparation of Mid-day-meal and provision of soap/liquid for children to wash their hands in the schools.
- e) Proper provision for waste water and other material if any.
- f) Provision of dust bins in every class room which should be neat & clean.
- g) The drinking water tanks should be cleaned every three months & the date of cleaning should be mentioned in a particular register.
- h) Material of Mid-day-meal should be placed at a neat & clean place.
- i) Students should be made aware about their health and nearby cleanliness through Eco-clubs, NSS/NCC camps & other voluntary organizations.

You are requested to take necessary action, under intimation to this office.
